A Year of Anniversaries

This year of 2005 is a year of 150th anniversaries. The Sandusky Schools are celebrating the first graduating class, St. Mary's Parish is celebrating its founding and the Erie County Fair celebrated the first Fair in Erie County. St. Mary's Parish, formed by the German families in the area, built their first church in 1855 on the corner of Decatur and Jefferson Streets. They also built a rectory and a schoolhouse. The cornerstone for the present church building was laid in 1873 and the building was dedicated in 1880.

The first directors of public education in Sandusky, Eleutheros Cook, Francis Parish and Samuel Caldwell, built a high school and three elementary schools in 1845. The high school was on the present Court House square, facing Columbus Ave. The first graduating class consisted of four girls – Sara and Martha Root, Helen Norris and Emma Bouton. This building was replaced by the present Adams Junior High building in 1869. The two elementary schools, one on the corner of Franklin and East Market Street and the one on Fulton Street and West Market are still standing, but the one built on West Madison Street is gone. The present older elementary buildings, which are now in danger of being torn down, were built between 1874 (Barker) and 1894 (Monroe). Sandusky was one of the first Ohio towns to establish a public high school.

Also, early in October of 1855 the first Erie County Fair was held on the south end of town on Monroe Street between Lawrence and McDonough Streets. Previous fairs were held in conjunction with Huron County. In April they announced all the awards that would be given – to the best farm, the best barn, the best implements and the best of each kind of farm animal. There were also awards for quilts, needlework, knitting, rag rugs, painting and flower arranging. The fair was counted a great success but there was not another one in Sandusky until 1865. Then the fairgrounds were established south of Scott Street between Columbus Avenue and Hancock Street.

Erie County Historical Society has placed a marker on Wayne Street marking this fairgrounds. In 1900, after this land was sold for development, the fairs were held on land on the north side of Perkins Avenue, between Camp and Mills Streets, where MacArthur Park is now located. The last fair held there was in late October of 1928 and there was snow that fell during the fair.

After World War II, Fall Festivals and 4-H Junior Fairs were held in various locations, including Strobel Field and Cedar Point, until 1957. Then the County leased land to the Agricultural Society that had been part of the Erie County Home Farm and a permanent Fairground was once again established.

The Heritage Society of Erie County, of which we've been an interested party since its beginning in 1984, seeks to preserve the agricultural and domestic history of the area. Artifacts are displayed in a reconstructed 1890 barn, moved from Avery, and the Carl Dahm Pavilion behind it. Agricultural machinery is displayed in the surrounding area. Prize exhibits are a 1918 Sandusky Tractor by Dauch Manufacturing and a 1922 Courier Car, both built in Sandusky.

Veterans History Project: Preserving Stories of Service for Future Generations

The Veterans History Project is a nationwide program that helps preserve the history of our nation's war veterans through the collection of oral histories and documents from those who served. Sandusky Library is an official Partner Archive for this project. Serving Our Seniors Seeks Drivers

Serving Our Seniors is seeking help from the community for our Out of Town Medical Transportation Program. Older residents use this service to keep their appointments for healthcare specialists such as cardiologists, oncologists, dialysis, etc.

Serving Our Seniors has seen an 81% increase in out of town medical transportation in the last year. In 2004, Serving Our Seniors funded 516 out of town trips compared to 285 in 2003. The increasing demand and associated costs for our out of town medical transportation is exceeding available funding, and with the growing number of older adults due to the aging baby boomer generation, we expect this trend to continue.

To remedy the problem, Serving Our Seniors is working to recruit volunteer drivers. By staffing this program with two volunteer drivers per day Monday thru Friday, we anticipate a cost savings of approximately \$10,717.00. This will position the Out of Town Medical Transportation Program to help 552 Erie County elderly, who are medically stable, keep their necessary appointments.

We are asking volunteers to drive just one (1) day per month Monday thru Friday. Volunteers will use cars provided by Serving Our Seniors to transport seniors to medical appointments. An organizational meeting of the Erie County Historical Society was held in the Community Room of the Sandusky Public Library on February 19, 1953. Considerable interest in forming a permanent organization was exhibited and temporary officers were appointed. They were:

Mary McCann, librarian of the Sandusky Public Library was the discussion leader at the initial meeting.

The Committee members met on February 24, 1953 and decided on the name, dues, membership, officers and committee chairmen.

The second meeting of the Erie County Historical Society was held on March 19, 1953. The following officers were elected:

The name Erie County Historical Society was officially adopted. Dues \$2.00 per year. Plans and aims of the group were discussed at the March 19 meeting. Dorothy Allen was the first paid member.

At the Board meeting held on April 14, 1953, Mrs. George Doerzbach was made the first honorary member. Meetings will be held four times a year, in October, January, March and May. A membership card form was decided upon. A Publicity Committee was set up with Mrs. Edward Lay as Chairman, with committee members, Miss Lucille Hutson, Dorothy Allen and Wilma Sauvey.

The following suggestions were drawn up by Miss Lucille Hutson and were used as the basis of the purposes and aims of the Erie County Historical Society:

- NAME - THE ERIE COUNTY HISTORICAL SOCIETY
- PURPOSE -
- To discover, collect and preserve whatever relates to the history, biography, archaeology and genealogy of Erie County, Ohio.
 - To obtain members living in Erie County or elsewhere who are interested in these subjects or who have special interests that could be classified as historical.
 - To hold meetings for the instruction and entertainment of its members.
 - To extend knowledge of the Society's collections by publication or other means.

ERIE COUNTY HISTORICAL SOCIETY

- REPOSITORY - There should be a museum at some future date.
- CHARTER - The Society should have a charter.
- MEMBERSHIP - There will be a CHARTER MEMBERSHIP to be closed on June 1, 1953.
- There should be a plan for securing members in all parts of the county and elsewhere.
- Printed membership cards will be issued showing membership and payment of annual dues.
- FUNDS - It should be a non-profit organization. Annual membership dues shall be \$2.00 per year. In time, operating funds may be obtained from other sources such as donations or bequests.
- PUBLICITY - Meetings should be well planned far enough in advance so that there can be proper publicity. Growth of the organization will depend upon this.
- There should be a bulletin issued at certain times telling about gifts received and anything else of interest to Society members.
- AIMS - To serve the community wherever possible.
- Immediate and long range aims to be discussed and planned by the members.
