## **CITY SUFFERS \$400,000 FIRE LOSS**

SCHMIDT BLOCK, HOUSING FIVE STORES, DESTROYED; HELP QUICKLY SENT Losses On Stocks Hea

The loss was roughly estimated at \$900,000, including the buildings all owned by 1 the Schmidt estate, and the mer-1e chants who occupied the store rooms, - while the insurance will amount to about \$220,000. The J. H. Herman furniture store d was destroyed and while the exact ·e loss could not be learned it was said :e taht a large shipment of stock just ۱t. received would bring the total up to 10 n at least \$40,000 Mr. Herman will

realize about onehalf insurance. le The clothing and shoe store of Moi-

f ris Nobil, which was the first to be destroyed, was nothing but a mass of charred ruins when firemen declared the danger past Mr. Nobil estimated his loss at about \$50,000, stating that 11. he had just recently received his com-

plete stock for the summer business, 'I have about one-half insurance,"

said Nobil. The Bismark cafe, owned by the B. J Sexton Co., adjoining the new >f h Schmidt block, was ruined at a loss of about \$15,000, according to the mana-

ger, Conrod Kreimes. The fire spread 10 rapidly into this section of the block

from the Nobil store and the only at. thing saved was the large electric sign

in front.

The J. J. Healy drygoods store was the last to take fire and while it was not so seriously burned as the others the loss is placed at about \$20,000, 0 largely due to smoke and water, with percent insurance. The Bowser ır

and Sharp store on the second floor incurred a loss of about \$5,000 on furniture and stock. Much stock was r†

removed. ۶đ.

When the wind shifted to due east le after the fire had gained full headway 5. in the Schmidt block it was feared that the flames would spread to the 18 nd Cohn, Herb and Myers and Scheuer rs stores in the next block west, but be only hte awnings were burned Part of the fire department responded to ۰v a call fro mthe rear of the Knox store but no blaze was found except a few men.

Losses incurred in the fire were sparks smouldering on the concrete

The barn in the rear of the Wassner saloon, owned by Philip Wassner, was totally destroyed with its contents, of hav, several light wagons and two buggies Damage was not estimated Practically no insurance.

The Wassner saloon and residence, owned by Wassner, was not badly damaged by fire Water and smoke did considerable damage to the rear of the residence Two-thirds of this entire property is covered by insurance

The residence adjacent to the Was-ner saloon, owned by Philip Wassner occupied by Mrs Etta W. Brown, was not damaged by fire, Water and not smoke caused a light loss


The garage of Dr C R Knoble, in the rear of his residence on Wayne-st, was totally destroyed Paint on the house was badly scorched, and repainting will be necessary and there was slight damage to the roof Loss estimated close to \$100 Insurance, half of loss

The fire began to yield to the hard fighting at 10:15 and within the next half hour appeared t obe under full control

Spurts of flame, however, prevent- ; c ed any official from making a positive declaration that the battle was won, and at 10.45, the third floor ceilings on the west end of the ruined building gave trouble Flames shot through the windows and another line of hose was added to the two that had already been placed George Upp, express wagon driver, handled one nozzle and held his position in the face of a blasting heat The pressure of water, at times, appeared to drop and then pick up with a force that nearly jerked the firemen from , f their dangerous position, high above the heads of the crowd of spectators 1

Police, members of both the night and day force, were doing emergency work and in many cases, were t compelled to use force to keep peo-ple back of the fire lines. The lines if ple back of the fire lines were early established but hundreds | broke through them

City Manager Ward was on the scene soon after the alarm was first sounded, making the trip in the police patrol He directed the work when the blaze was yet confined to the small barn He later surrender-ed his place of authorit yto Fire Chief Hegemer, but throughout the hours of fighting, he kept in close touch with the small army of fire-


